The use of other personal information contained in this form is collected by CA and the Association for the purpose of administering Cricket Australia Junior Participation Programs and to ensure that participants (and their parents and guardians) are kept informed of junior cricket initiatives, giveaways and competitions which CA or the Association conducts from time to time.
